



### **MINUTES OF MEETING OF EXECUTIVE BODY OF HPOS**

Meeting of the executive body of Himachal Pradesh Ophthalmological Society was held on 10-11-2018 at Rotary Eye Hospital Maranda Palampur under the chairmanship of Dr. S. K. Soni President of the society.

After welcome by the President Dr. Jitender Singh Roodkee General Secretary of the society proposed following points and were discussed in detail.

1. For the purpose of various activities to be executed by the society whole state is to be divided into three zones.

Zone I will include Shimla, Kinnaur, Solan and Sirmaur.

Zone II will include Mandi, Kullu , Lahaul - Spiti and Bilaspur

Zone III will include Hamirpur, Una, Kangra and Chamba.

2. Efforts to be done for the Strengthening of HPOS body by collection of funds .For last three years members has not given yearly subscription Rs 500/=

3. It was proposed that HPOS website may be outsourced and responsibility may be given to some pharmaceutical house. It was also proposed that directory of members to be updated .
4. It was also suggested that old executive body should hand over the charge of the society to the new executive body by the next meeting of the executive body preferably 3 months
5. CME credit hours :- It was proposed that all CMEs to be conducted should have CME credit hours sanctioned by the appropriate authority. Curriculum of the CME should also include free paper session focusing on the interest of PG students.
6. Equipments at Health Institutes: - It was proposed to make efforts to strengthen Civil Hospitals and District hospitals and all other health institutes where eye surgeons are available by providing Equipments required for providing Ophthalmological Services. It was decided that proposal to the Government is to be sent for uniform instrumentation of Civil Hospitals and Distt Hospitals and availability of Phacoemulsification Unit .
7. Training of Eye Surgeons :- Executive body was of the opinion that Eye Surgeons require training for remaining conversant with recent advances. It was decided that proposal should be sent to the government for identifying and setting up of training institutes in the state. It was proposed that such curriculum, training manual and schedule of the training should be developed and proposal may be sent to the appropriate authority.
